Legal information

Administrative data is collected in accordance with Section 48 (1) of the North Rhine-Westphalia Higher Education Act in conjunction with Paderborn University's enrolment regulations. Statistical data is collected on the basis of the Higher Education Statistics Act (HStatG). According to this law, the individual details about your personal and factual circumstances must be kept secret by those authorised to provide information. However, it is permissible for the statistical offices and the university collecting the data to pass on individual details without mentioning your name and address to the competent supreme federal and state authorities and to the bodies and persons designated by them on request and insofar as this is possible without jeopardising confidentiality - by the statistical offices for scientific purposes. The universities may also use your data for internal university purposes, including your name and address, and forward it to the new university for its internal administrative purposes in case of a university change (see also the General Data Protection Regulation (GDPR), the Federal Data Protection Act (BDSG) and the Data Protection Act of North Rhine-Westphalia (DSG NRW), as amended).

- all other necessary records listed in your notification of acceptance

additionally:

-electronic notification from a German statutory health insurance fund, sent via the SMV ("Studenten Meldeverfahren") in accordance with § 199a SGB V (*social code V*). Also students who aren't members of a statutory health insurance fund must also contact one in order to notify the university of their insurance status

Only if you are applying for a German-taught course and your higher education entrance qualification was not gained at a German-speaking institution:
