<u>A</u> Information about the duty to maintain data confidentiality

I was advised of the duty to maintain data confidentiality according to § 6 of the Data Protection Act North Rhine-Westphalia - DSG NW - dated June 9, 2000 (GV.NRW.S.542). According to § 6 DSG NW, it is forbidden to process or disclose protected personal data accessible in official capacity without authorization for a purpose other than for the respective lawful performance of the task; this continues to apply after the end of employment. I have been informed that violations of data confidentiality can be punished with imprisonment or a fine, particularly pursuant to § 33 DSG NW; this class not exclude disciplinary or labor law measures. In most cases, a breach of data confidentiality will at the same time constitute a breach of official confidentiality or a breach of the duty to maintain confidentiality, and may also constitute a breach of special confidentiality obligations.

<u>B</u> Declaration of compliance with the constitution

I have been informed of my duty to comply with the constitution and that participation in efforts directed against the free democratic basic order or against its basic principles is incompatible with the duties of a member of the public service. On the basis of the instructions given to me, I hereby declare that I will always fulfill my duty to uphold the constitution, that I will affirm the principles of the free democratic basic order within the meaning of the Basic Law and that Partneady at any time through my entire conduct to commit to the free democratic basic order in the sense of the Basic Law and to stand up for its preservation.

I expressly assure that, will in no way support efforts or belong to organizations whose goals are directed against the free democratic basic order or aim to impair or endanger the free democratic basic order.

I have been instructed that if I work or if I conceal my work in one of the above-mentioned organizations, the employer is entitled to terminate the contract without notice.

<u>C</u> Formal obligation of non-civil servants
